<b>Key duties of this position</b>	<ol style="list-style-type: none"> <li>1. Lead a Patrol Team</li> <li>2. Assist with the Development of the Clubs POM in conjunction with Lifeguard Director</li> <li>3. Monitor and ensure delivery of the POM</li> <li>4. Ensure all patrol documentation is completed and inputted on the Patrols and Membership Database by 5pm each Wednesday following patrol</li> <li>5. Ensure lifesaving assets are at, and maintained to a level appropriate for the demand/need of the Club (within budget constraints)</li> <li>6. Ensure that all Lifeguards have completed their refreshers prior to commencing patrols.</li> <li>7. Submit Rescue of the Month information to the Lifeguard Director/Lifeguard Sub-Committee</li> <li>8. Report to the Lifeguarding Sub-Committee on the above</li> <li>9. Undertake any other activities as required by the Lifeguarding Sub-Committee</li> </ol>
